

## MAKEMUSIC! EXTRANET ACCESS AGREEMENT

### **THESE TERMS OF USE ARE AN AGREEMENT BETWEEN THE BUSINESS YOU WORK FOR AND MAKEMUSIC!, INC. ("MakeMusic!"). PLEASE READ THESE TERMS OF USE CAREFULLY.**

This Extranet Access Agreement applies to MakeMusic's Extranet site, with a homepage located at <http://dealers.makemusic.com> (the "Site"). "You" or "your" refers to the business you work for, or yourself if you are self-employed. This Extranet Access Agreement describes the rules that apply to your use of this Site. You are responsible for ensuring that your employees who access this Site follow these rules.
